

# Eligibility

Applicants must have successfully completed an ACGME-accredited PGY-1 clinical year of training prior to being accepted. The program is also encouraging applications from those that have completed a residency in primary care for the maternal and child health track.

Completed applications will be accepted between September 1st and December 31st of the year prior to entry, with interviews planned to start in November. This program participates in the SAP, dates are subject to change.

Applicants must be US citizens or lawful permanent residents (Green Card).

Interested applicants may submit their complete application package with the following documents:

- ERAS application
- Curriculum Vitae
- Copy of undergraduate transcript
- Official graduate degree transcript, if applicable
- Official Medical School Transcript
- Copy of Medical School Diploma
- ECFMG certificate, if applicable
- Dean's Letter
- Official USMLE transcript or score reports from all attempts-passing scores on Steps 1, 2, and 3 required; also Step 2 CS (if required)
- ACGME Global Resident Competency Rating Form must be submitted directly from Program Director under which clinical training was completed
- Three current recommendation letters supporting your interest in Preventive Medicine

Applications are **NOT** accepted by email



Interviews are required and are by invitation only from the Residency Selection Committee.


Application materials are accepted through ERAS, fax, and/or US Postal Service.


## Why Preventive Medicine?

Residents receive compensation equivalent to the post-graduate year salary scale (PGY-2 and PGY-3) for residents at Meharry Medical College. Fringe benefits include health, life, and disability insurance, paid vacation and sick days, and malpractice coverage.

During the program, each resident has access to Meharry's CEPH-accredited MPH program and can benefit from our excellent relationships with Tennessee State University, Vanderbilt University, and multiple community organizations.
